Medical Treatment Authorization and Liability/Appearance Release

I understand that there are risks of physical injury (including but not limited to minor, serious, catastrophic and/or death) associated with, arising out of and inherent to the activity taking place at this event/facility. In recognition of the acknowledged risk of injury, I knowingly and voluntarily waive all rights and/or courses of action of any kind, including any and all claims of negligence, arising as a result of such activity from which liability could accrue to American GymStars, its employees, and all affiliated entities (hereinafter collectively referred to as “American GymStars”).

I hereby agree to release American GymStars harmless of all liability, and hereby acknowledge that I knowingly and voluntarily assume full responsibility for all risks of physical injury arising out of active participation in this event on behalf of the participant. I agree to comply with the instructor and/or supervisor of activity at all times while using the facility. Failure to comply with the instructor, staff or other employees or volunteers of American GymStars can result the loss of mine and my child's membership/class. American GymStars reserves the right to remove any participant from its facility/classes.

I, for myself, and on behalf of my heirs, personal representatives, and next of kin, hereby release, hold harmless and promise not to sue American GymStars, its officers, volunteers, staff, sponsors, and/or agents, or the instructor of the class (“releases”) with respect to any and all injury and/or loss arising from my participation, whether caused by the negligence of the releases or otherwise, except that which is the result of gross negligence or wanted misconduct, to the fullest extent permitted by law.

This waiver and release of liability shall remain valid until it is expressly revoked by written notice from me to American GymStars or the termination of my membership.

American GymStars highlights team-related events via Facebook, Instagram, Twitter, and our website. We may photograph participants during classes. I hereby allow American GymStars to record the participant’s likeness and use the image for promotion and media reporting and acknowledge that I have no right to inspect or approve the images prior to publication.
